Deposit:

Non- Refundable Deposit of \$ 250.00 made on date: _____ for above said cat/kitten. This deposit is not refundable but is transferable to another kitten should said cat/kitten does not pass a health guarantee. Deposit is valid until cat/kitten is picked up. Cat/kitten must be picked up within 12 weeks of age unless prior arrangements have been made or the cat/kitten is older than 12 weeks at the time of deposit.

Altering agreement:

This kitten is for:

(X) Pet only and must be altered. If unaltered by 6 months of age, person will be responsible for said cat/kitten and registration papers will not be made available to purchaser.

If said cat/kitten is not properly spayed/neutered, any kittens resulting from said cat/kitten will be relinquished to Whitney & Justin Antons- Antons Nebraska Maine Coons. No sales of kittens will be allowed without contacting Antons Nebraska Maine Coons or a breeding contract has been established.

When adequate proof of sexual alteration has been received, the Breeder will provide TICA registration paperwork to the buyer. "Adequate proof" is defined as paperwork (such as certificate of spay/neutering) from the veterinarian who performed the surgery.

Health Contract:

Buyer must have the cat/kitten evaluated by a veterinarian within **3 business days** of purchase to ensure the cat/kitten meets standards provided in the contract. Failure to do so will void the contract. The cat/kitten must be quarantined from any other cats for the first 14 days after purchase.

It is the responsibility of the Purchaser to provide immediate veterinary care to any cat/kitten showing signs of illness or distress and failure to do so will render any guarantee null and void. If a cat/kitten dies within the guarantee period, despite medical treatment, a replacement will ONLY be given if a veterinarian certifies the cause of death. All veterinarian fees are the sole responsibility of the Purchaser.

Said cat/kitten received their first set of vaccinations and health assessment. Purchaser will be responsible for all further vaccinations of kitten. Antons Nebraska Maine Coons agrees to provide the veterinarian documentation that cat/kitten is in good physical health and UTD with vaccinations.

This kitten will have a 1-year health guarantee of a congenital defect. If a congenital defect is found, the cat/kitten will be replaced for a cat/kitten of equal value when one is available. You can return the cat/kitten for replacement of cat/kitten of equal value if the cat/kitten tests positive to FeLV or FIP up to 14 days after purchase date. There is also a 48-hour guarantee from any respiratory illness at the time of the sale. You may return the cat/kitten if a respiratory illness is found within 48 hours and a replacement of cat/kitten will be provided within 6 months. Respiratory or a diagnosis of FeLV or FIP illness must be documented by a veterinarian and provided to the Seller. There are no guarantees against FIP.

This cat/kitten will never be sold, transferred, leased, or given away to any pet shop, research laboratory or similar facility. This cat/kitten will be kept indoors and not allowed to roam freely outside.

If this cat/kitten is found to be neglected or mistreated, Purchaser will surrender said cat/kitten to Seller, unconditionally. All fees associated with recovery of cat/kitten will be the responsibility of Purchaser including all court costs and attorney fees.

This contract gives Antons Nebraska Maine Coons the rights to post pictures of kittens on social media and website. Any disagreements resulting from the purchase of this cat will not be published by buyer, seller, or their associated/surrogates on social media or on any internet sites. Damages for violation of this clause will be \$5000.

This contract is legally binding to all parties involved. It applies only to the Buyer and Seller in this transaction and is non-transferrable to other parties. All legal fees incurred in upholding this contract will be paid by the purchaser.
